## Quiet Levers: Deeper Dives By State

## Arizona (AZ)

**Qualified Facility Tax Credit:** Arizona's flagship incentive for manufacturing and export. Substantial credits available for businesses investing in plant, equipment, and creating new high-wage jobs—especially strong for advanced manufacturing, aerospace, and tech.

**AZ Innovation Challenge Grant:** A highly competitive grant for high-growth startups in technology and bioscience. Winners receive funding, mentoring, and milestone support—ideal for early-stage companies ready to scale.

**Healthy Forest Initiative:** A specialized program supporting forest products businesses through direct payroll tax credits. Particularly impactful for rural employers and companies supporting wildfire mitigation.

California (CA)

**California Competes Tax Credit:** A competitive, high-value program for ambitious hiring and investment projects. Ideal for those scaling or relocating within CA.

**Small Business Hiring Tax Credit:** Best for small employers looking to recover or grow headcount. Works alongside state and federal wage subsidy programs.

**EV/Solar Exemptions:** For sustainability-focused businesses, the sales/use tax waiver can dramatically improve ROI on new equipment or infrastructure.

District of Columbia (DC)

**Chinatown Long-Term Lease Grant:** Supports long-term business tenancy and cultural preservation in the Chinatown area—critical for sustaining heritage businesses.

**Great Streets Storefront Grant:** Up to \$50K to improve street-level retail; great for revitalizing commercial corridors and boosting curb appeal.

**DC Innovation Finance (BizCAP/IFP):** Supports startup/early-stage business growth; works as gap financing alongside private capital.

Florida (FL)

**Rural Job Tax Credit:** If you're creating jobs in Florida's rural counties, this incentive provides direct cash benefit. Great for distributed teams or relocators.

**Community Contribution Tax Credit:** An underutilized lever for businesses supporting affordable housing or community renewal—turns investments into tax credits or refunds.

**Qualified Target Industry Tax Refund:** A classic for targeted industry hiring; pairs well with aggressive growth or relocation in strategic sectors.

Massachusetts (MA)

**EDIP:** The Economic Development Incentive Program is MA's flagship incentive; essential for businesses planning significant hiring or capex. If you're ready to commit to expansion and job creation, this lever could unlock six-figure credits and/or local property tax relief.

**R&D Tax Credit:** A proven benefit for MA companies developing products, tech, or processes. If you're investing in innovation, this should be in your annual tax plan.

**Investment Tax Credit:** Particularly valuable for manufacturers, R&D firms, or renewable energy adopters investing in property or equipment—offers a direct credit against state tax liability.

Maine (ME)

**Dirigo Business Incentive Credit:** A strong choice for expanding or modernizing your Maine facility or equipment. Good fit for growing companies reinvesting in infrastructure.

**Work Opportunity Tax Credit:** Aligns hiring with social impact. Useful for companies ready to diversify or expand with priority groups (veterans, long-term unemployed, etc.).

**Grow Maine Loan (FAME):** Flexible, low-interest financing for expansion, working capital, or equipment—works well as part of a larger capex or hiring initiative.

Montana (MT)

**Big Sky Economic Development Trust Fund:** Competitive grants for business expansion, especially those creating new jobs. Great for businesses investing in facilities or equipment in rural and urban Montana.

**Montana Incumbent Worker Training Program:** Reimburses training costs for existing workers. Ideal for businesses upskilling their teams to meet growth or operational goals.

**Montana SBIR/STTR Matching Funds:** Provides matching grants for Montana businesses that have received federal SBIR/STTR awards. Excellent fit for tech, research, or product innovation firms seeking to stretch their grant dollars further.

New Hampshire (NH)

**Coös County Job Creation Tax Credit:** Ideal for businesses expanding or hiring in Coös County—offers meaningful per-job credits at higher wage levels, making it a smart fit for companies seeking to grow payroll and contribute to local workforce development.

**Economic Revitalization Zone (ERZ) Tax Credit:** Perfect for those planning infrastructure or facility investments in designated zones. The five-year credit is substantial for manufacturers, tech, or service businesses looking to anchor or expand in NH.

**WorkInvestNH Training Grant:** A match-grant model for upskilling your team. This lever is best used for scaling talent and meeting the skills gap that often emerges at midyear growth checkpoints.

New Jersey (NJ)

**Small Business Improvement Grant:** Direct reimbursement for capital improvements; great for brick-and-mortar and service businesses refreshing space or capacity.

**Small Business Fund:** Financing designed for under-\$10M SMBs; helps bridge gaps for asset acquisition or working capital.

**Business Marketing Grant:** Substantial state support for companies expanding marketing, relocation, or outreach initiatives.

New York (NY)

**Youth Jobs Program Credit:** A powerful way to bring on young talent while accessing meaningful per-hire incentives. Particularly strong for seasonal, retail, or service firms.

**Employee Training Incentive:** Offsets the cost of workforce upskilling; critical for keeping teams competitive in evolving markets.

**Global NY Export Grant:** Enables international growth by helping to defray costs tied to exporting or entering new markets.

Texas (TX)

**45V Hydrogen Credit:** Leading-edge energy tax credit, ideal for firms in clean tech or hydrogen production—can make or break large capex projects.

**Film/TV Incentives:** For creative industries, these incentives can be decisive in project location and hiring choices.

**Chapter 380/381 Agreements:** Extremely flexible, locally negotiated packages; leverage these for major job, real estate, or capex initiatives.

Virginia (VA)

**Enterprise Zone Program:** Pairs state and local incentives for job creation and capital investment—especially valuable for businesses expanding in priority zones.

**Small Business Financing Authority:** Low-cost working capital or capex loans for qualified Virginia businesses—designed to fuel sustainable growth.

**Film Production Incentives:** A driver for creative businesses producing or spending in Virginia—encourages local spend and talent engagement.
